c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

The system is used to automate the management of the Air Force Foreign Military Sale (FMS) operations associated with the creation of manpower requirements packages (MRP) in accordance with a Letter of Offer and Acceptance (LOA). This system currently delivers the development of Foreign Military Cases to allow users to input their manpower requirements for MRPs and allows them to go through a predefined review and approval process with their organization, MAJCOM and SAF/IA. SAMRS is utilized by the AF Security Cooperation community in developing manpower cost estimates to respond to Letters of Request and presenting partner countries with Letters of Offer and Acceptance for FMS cases. Records may also be used as a management tool for statistical analysis, tracking, reporting, evaluation program effectiveness and conducting research. SAMRS is the automated System of Records (SORs) for USAF FMS direct case-funded MRPs.

PII collected: Name, rank/grade, work phone, work email address, Air Force Portal Identifier (AFP ID), MAJCOM, Workcenter, Organization, work location/base, and role/position.

Intended for identification/authentication purposes for use of the SAMRS system also mission-related use as it relates to FMS.
